Committee Updates: Reviewed vendor materials and educational brochures. Feedback was incredibly positive, and modifications were made. Herman will update “Diners with Disabilities” brochures to broaden audience from restaurant industry to all businesses.

Artability Preparations: Call for Art posters are displayed in all SAM fixed-route buses as well as paratransit. Herman will reach out to the Empire Mall to inquire about marketing in an empty store front. Richardson shared that Lifescape’s Mall Walk is scheduled for February 4th, so ideally we would have display set up before then.

Initiatives for consideration was tabled until after Artability.

Reviewed bylaws with Schlimgen advising there have not been any changes in governing law. Herman motioned to adopt existing bylaws. Motion seconded by Jorgensen and passed unanimously, 8-0.

Officer Elections: Motion made by Herman and seconded by Zepeda for Zwart to remain as Chair. Motion passed unanimously, 7-0. Motion made by Barnhardt and seconded by Herman for Jorgensen to remain as Vice Chair. Motion passed unanimously, 7-0. Motion by Jorgensen and seconded by Barnhardt for Lipp to be elected Secretary. Motion passed unanimously, 8-0.
