- 2) Draeger requested Traffic to look at the Horace Mann school zone at intersection of 26th.
- *City Engineering:*
 - 1) Motion by Draeger to accept the 2018 meeting dates. Second by Reuter. All approved, motion passed.
 - 2) Cazer discussed changing the PATH map for the Harrisburg Explorer Elementary school. It would add the south side of 77th Street between Shadow Creek Cir and Beal Ave and the E side of Beal from 77th St to the Elementary School. Cazer will bring an updated map for board approval in January 2018.
 - 3) Parking issues on Olive Drive near Cleveland Elementary. It was suggested to change the “No Parking from Here to Corner” to “No Stopping, No Standing, No Parking”. Will bring back to January meeting to approve.
 - *Private Schools:* Lewis-Huemoeller discussed a parent concern to eliminate the “No Turn on Red When Pedestrians Present” sign at the 26th & Marion intersection to a no turn on red. This would make the turns easier to leave St. Michaels Church. Miller will talk with Hoftiezer about this and report back in January.
